- The option is exercisable as to 6,417 shares. The option vests as to two equal installments of 6,417 shares on August 13, 2020, and 2021. The option becomes exercisable as to the remaining 6,416 shares on August 13, 2022.
- The option is exercisable as to 5,592 shares. The option vests as to two equal installments of 5,592 shares on March 26, 2021, and 2022. The option becomes exercisable as to the remaining 5,591 shares on March 26, 2023.
